**4.3. Indication of any immediate medical attention and special treatment needed**

**5.1. Extinguishing media**

**Extinguishing media:** Alcohol resistant foam. Water spray. Carbon dioxide. Dry chemical powder. Use water spray to cool containers.

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.
